Dear colleagues,

We know that the whole world is watching the events in Ukraine today with great sadness. As the results of the latest UN General Assembly demonstrated, the whole world is shocked by this barbarous war that Russian Federation began on 24 February 2022 against Ukraine. It touches directly the Ukrainian civilians and leads to the death of innocent people - over the course of the 7 days of war, 2,000 civilians have been killed by the Russian occupation forces. They're also destroying social infrastructure and shooting down neighborhoods. This kind of actions of the Russian Federation cannot be justified.

Ukrainian heroes do not only stand for the independence of our country and for the life of our people, but also for the values of democracy, human rights and integrity.

In these hard times our anti-corruption institutions do everything possible to serve our country, and stay resilient. The e-register of asset declarations for public officials which was launched back in 2016, is still up and running. Judges of the High Anti-Corruption Court of Ukraine continue delivering justice amid regular air raid alerts in Kyiv. Although the SWAT teams of the National Anti-Corruption Bureau regularly patrol Kyiv's government quarter, its detectives continue investigating high-profile corruption cases and safeguarding the collected evidences.

We trust that anti-corruption bodies of other governments share our aspirations and our commitment for integrity, freedom, and independence. On behalf of the National Agency on Corruption Prevention we ask you to add you voices to those who condemn this barbarian attack of the Russian Federation and to urge your governments to come up with timely and bold decisions that would contribute to the end of this crisis.

We believe that harsh sanctions should be imposed on Russia in any possible sphere to sober its leadership and nudge it to the use of peaceful instruments of interaction with other states.

We would also appreciate any assistance given to the Ukrainian government. Today we clearly see that the international support given to Ukraine in form of arms and financial guarantees thought 2014-2021 is one of the strong pillars that allow our army to resist Russian troops.

Yet, one of the main demands of Ukrainian people today is to close the sky over Ukraine, cutting the possibilities for Russian army to shell our citizens and destroy our infrastructure.

In this war the Ukrainians demonstrate unique unity fighting for their choice and their European future. We ask you also to be united and support Ukraine on its path to democracy and victory.
